BYLAW NO. 2015-MC-03

A BYLAW TO PROVIDE FOR THE REMOVAL OF SNOW, ICE AND OTHER OBSTRUCTIONS FROM SIDEWALKS.

The Council of the Town of Maple Creek, in the Province of Saskatchewan, enacts as follows:

- 1. The owner or occupant of property within the Town of Maple Creek which has a sidewalk that traverses the frontage and/or the flankage of said property must ensure that accumulations of ice, snow, dirt or any other debris or obstructions are promptly removed.
- 2. The Designated Officer or any other person acting on behalf of the Town of Maple Creek is hereby empowered to enforce the removal of snow, ice, dirt, and other obstructions from the sidewalks adjoining property of non-residents and all other persons who are:
 - (a) owners or occupants of a property that is zoned as C1 Commercial, C2-Commercial, M1-Industrial or CS-Community Service shall ensure that such sidewalks are cleared within twenty-four (24) hours of the completion/end of the event causing the accumulation; and
 - (b) owners or occupants of any other property other than those mentioned in Section 2(a) shall ensure that such sidewalks are cleared within thirty-six (36) hours of the completion/end of the event causing the accumulation; and
 - (c) owners or occupants of any property shall ensure that water draining from a roof or eaves upon a sidewalk or roadway that the sidewalk or roadway is cleared to prevent ice from forming thereon.
 - (d) owners or occupants of a property who runs an extension cord across a public sidewalk for any reason must do so in such a way that the extension cord is suspended a minimum of 2 metres (6 feet 6 inches) above the sidewalk without any obstruction on the sidewalk so as to allow the safe passage of pedestrian traffic underneath the extension cord.
- 3. Owners or occupants of property may remove snow and ice from property on any street when:
 - (a) Mounds of snow are not created; (snow must be feathered out; no deeper than 10 centimeters (4"))
 - (b) That the said snow is placed on any street within twenty-four (24) hours of the completion/end of the event causing the accumulation;

- 4. No person shall:
 - a) fail to comply with an order made pursuant to this Bylaw;
 - b) obstruct or interfere with any Designated Officer or any other person acting under the authority of this Bylaw; or
 - c) fail to comply with any other provision of this Bylaw.
- 5. Every person who contravenes any provision of this Bylaw is guilty of an offence and liable on summary conviction:
 - a) in the case of an individual, to a fine of not less than \$50.00 and not more than \$10,000.00;
 - b) in the case of a corporation, to a fine of not less than \$100.00 and not more than \$25,000.00; and
 - c) in the case of a continuing offence, to a maximum daily fine of not less than \$50.00 and not more than \$2,500.00 per day.
- 6. That Bylaw No. 2014-MC-12 is hereby repealed.
- 7. This Bylaw shall come into force and be in effect on the date of third and final reading by the council of the Town of Maple Creek.
