

Dear Mr. Hughes:

Thank you for your letter regarding your request to have ice rinks included in the same rate class as farms for SaskPower billing purposes. Minister Duncan has asked me to respond to your letter on his behalf.

The Saskatchewan Rate Review Panel oversees SaskPower rates and classes to ensure customer are being treated fairly. Rate classes are designed to group customers together that have similar usage and similar infrastructure requirements. I understand that you are trying to find ways to reduce your operating costs but because of the differences in usage it would not be appropriate to put a rink in the farm rate class as other customers would then unfairly subsidize the rink accounts.

SaskPower knows that rinks are the hub of rural communities and electricity is a significant factor in their overall operating costs. Our Municipal Ice Rink Program may be of assistance to you as it offers technical assistance and some limited incentives for efficiency projects.
