I am writing to you about the results of the Ministry of Justice, Courts and Tribunals Division's, review of fine revenue distribution within the new database system, Criminal Justice Information Management System (CJIMS).

Since my letter on November 15, 2016, we commenced utilizing CJIMS on January 30, 2017. As is good practice with system changes of this magnitude, we recently undertook a review of all commissions and fine revenue distribution. This review has identified two areas that require our follow up:

1) New account referrals to collection agencies - All new account referrals to collection agencies, since the inception of CJIMS until July 31, 2017, did not distribute holdback commission amounts to collection agencies correctly. While no money was lost, when revenue was received during this time period, the collection agency commissions were paid to municipalities rather than to the appropriate collection agency.

As a result, it was determined that your town will not have an adjustment to revenue.

2) Fine revenue - Some municipalities entitled to fine revenue were setup incorrectly in CJIMS. We are in the process of identifying which organizations have been affected by an underpayment, and calculating the amount of the underpayment. We will confirm with you in writing the impact of this review on your town in the coming weeks.

The Ministry of Justice remains committed to regular reviews to ensure accurate disbursement of revenue and commissions. If you have any questions, please do not hesitate to contact Curtis Kosolofski, Director, Financial and Corporate Services, at (306) 787-5972.
